Vodafone Ukraine announces Q3 2021 performance results

Vodafone Ukraine Group of Companies improved its key financial indicators in the third quarter of 2021. The Group's revenue in July-September 2021 amounted to 5.2 billion UAH, which 8% more than in the same period last year.

The other Group's financial indicators also show the steady growth in Q3 2021 compared to the same period in the prior year. OIBDA increased by 10% to 2.8 billion UAH. The OIBDA margin increased by 1.0 p.p. to 54.4% YoY. The net profit exceeded UAH 1 billion.

The main growth factor was the increase in the consumption in voice&data tariffs. The gradual recovery of roaming revenue also contributed to the revenue growth.

In the third quarter Vodafone Ukraine completed the purchase of Vega. The purpose of purchasing for Vodafone Ukraine is further business development in the field of telecommunications, in particular, fixed-line services.

Vodafone Ukraine's capital investments in the 3rd quarter of 2021 amounted to 591 mln UAH, most of them – in the development of high-speed Internet infrastructure. The Company's total investments in the construction of high-speed mobile Internet networks totalled 30.9 billion UAH.

The focus on the 4G network development and an increase in the number of data users aroused an increase in the consumption of data services and, accordingly, ARPU by 9% compared to the same period last year, the indicator was 86.4 UAH in the third quarter of 2021.

Vodafone customer base shows an upward trend (+ 0.1%) and reaches 19 million customers. At the same time, there is growth in the segment of contract and corporate gross-adds, the number of new connections in the IoT segment is steadily growing.
